Exposure to Covid – Customer/Visitor to Staff	Staff Customers Visitors Vulnerable Persons	Retail area is restricted by headcount, only limited customers in store Floor markings indicate 2m social distancing. Staff are required to wear face masks when interacting. Customers will also be required to wear masks for their protection, the protection of other members of the public and for the protection of our employees. While it is understood that legally some members of the public are not required to wear a mask, it is not possible for staff to confirm whether they are exempt of not. Even if a member of the public is legally exempt, not wearing a mask presents a clear risk. It has accordingly been decided that if a customer refuses to wear a mask, the following adjustments should be made:  An offer should be made to serve them outside the store; AND An offer should be made to arrange for a click & collect outside the store; AND An offer should be made to serve them in store once the store is empty of other members of the public; AND Where a member of the public states that they have a face covering exemption, then in addition to the above options, they should also be offered either a face covering, or a face visor (ECP Pt JTA.8000.2425. They are not expected to return these items and they should not be re-used.  Staff/customers are separated by Perspex screens Hand sanitisers are available All touch points — card machines etc are wiped after every use. Increased cleaning regime on all touch points — door handles etc. Prominent signage to display control measures to customers.  If a member of staff has a valid reason for not wearing a face mask, they can also be issued with a face visor as above, this can be re-used as it will be personal issue. This is for exceptional cases only and not an alternative to wearing a mask if there is no valid reason not to.	Monitor and Maintain. Adjust as necessary.
